IMPORTANT HEALTH & SAFETY RESOURCES FOR MEMBERS

With regard to your health and safety at work, Unite has a wealth of information on its website for you to check and use in your workplaces.

Firstly type this link into your browser – it is the home page for the East Midlands.

There is a H&S Resources link you can click on to access everything from asbestos to COSHH, dust to ventilation. You will also be able to download guidance on risk assessments and posters that you can use in your workplaces.

Did you know that the asbestos questionnaire is now available to complete online? If you think you have been exposed to asbestos it is important to keep track of where, just in case. Unite's Asbestos Register keeps all your information securely and centrally in the event of any claim which has helped our Solicitors and members if they have to pursue an asbestos related claim. If you work with lead (dust, fumes, vapour), or are regularly exposed to diesel emissions, Unite also has registers for these. The idea is to maintain a record of where you worked at that time, should you develop an illness related to exposure. The problem is that they can occur years later and you may not be able to remember where you were exposed for example. This makes it much easier for our solicitors to build up a claim in the event. Also, if any of the companies have closed then it is likely that insurance companies can be traced.

In terms of asbestos related claims, these are our predecessor unions that make up Unite, so even if you were part of them before and rejoined later, please contact the legal helpline on 0800 709007 and they will be able to discuss a claim with you.
